# 2024 Legislative Priorities



Catholic Charities' 2024 legislative priorities aim to strengthen our direct service programs and address systemic inequities in housing. Together we can disrupt trends in homelessness and help people achieve stable housing that is foundational to their health, education and employment success.

## **Sustainable Emergency Shelter Operations**

Investments made by the 2023 Legislature are supporting emergency shelter operations throughout the state, but after years of underinvestment, providers like Catholic Charities continue to experience significant budget shortfalls for their most essential services. Without additional public aid, shelter safety net programs — including those providing basic needs and access to healthcare, housing navigation, employment services and more — risk reducing services for the most vulnerable in our communities.

#### **Catholic Charities supports:**

- State aid to address immediate budget shortfalls for emergency shelter operations.
- The development of a more sustainable, predictable funding model for shelter operations and providers.
- Efforts to clarify the roles of government jurisdictions in responding to the homelessness crisis.



The number of people served at Catholic Charities' St. Paul Opportunity Center, an emergency day shelter, increased 37% from 2022 to 2023.

#### Reducing Barriers to Supportive Housing

Minnesota's Housing Support program pairs housing assistance (e.g., rent, linens, laundry) with case management for low-income seniors, veterans and adults with disabilities who are at risk of homelessness. It is one of the state's best tools to prevent and end homelessness, but challenges driven by inequitable income formulas, eligibility and referral processes mean available units too often sit vacant while shelters are full and rates of unsheltered homelessness rise.

#### **Catholic Charities supports:**

- Extending Housing Support's 30% of income protections (passed in 2023) to include individuals with disabilities and veterans who reside in Board & Lodge settings.
- Adjusting the personal needs allowance for Housing Support residents who receive General Assistance.
- Simplifying supportive housing eligibility and referral processes to ensure our highest-risk neighbors are not told they "aren't homeless enough" to qualify for support.



Some Housing Support residents still pay up to 90% of their monthly income for housing. Many choose to stay in shelter or on the streets instead.

#### **Partner-Led Priorities**

Catholic Charities supports the advocacy of our partners to improve housing and homelessness outcomes, including:

- Clarifying the use of the Metro Sales Tax to fund recurring supportive housing expenses.
- Expanding tenant rights to include source of income protections.
- Improving coordinated entry systems to place residents in housing more quickly.
- Building more deeply affordable, accessible housing.
- Reforming Housing Stabilization enrollment and payment processes.

#### **Emergency Shelter Services**


Providing daytime and overnight shelter for youth and single adults experiencing homelessness.
